PURPOSE:

This Policy applies to all citizens outside of the Rural Municipality of Elton’s (Elton) boundaries who are approved and pay annually to deposit their bagged household waste and recyclables at one (1) of the three (3) transfer site within Elton.

The three (3) transfer sites for use by Elton’s citizens only are identified in By-law 1646 *Solid Waste and Recycling* which includes fines and are regulated and enforced through By-law 1637 *Establish and Regulate Enforcement and Penalties*. These by-laws would also apply to any citizens that apply and are approved to deposit their bagged household waste and recyclables only.

POLICY DESCRIPTON:

Citizens beyond Elton boundaries who request approval and pay the annual fee may deposit their bagged household waste and recyclables at one (1) of the three (3) transfer sites within Elton by completing the Request for Use of Transfer Site form attached to this policy. The approved citizen(s) must abide by By-law 1646 *Solid Waste and Recycling* which includes fines and are regulated and enforced through By-law 1637 *Establish and Regulate Enforcement and Penalties*.

Rates will be identified on the form and will be updated as necessary by Resolution of Council.

Citizens beyond Elton boundaries are not guaranteed approval to use transfer sites and approved users may be restricted or revoked access at any time if deemed in the best interest of Elton.

Citizens beyond Elton boundaries, who have not been approved to use Elton’s Transfer Stations, will be fined for using the site(s).
