POLICY DESCRIPTON:

Hourly

That Council policy be that Elton machinery rates are **\$100.00** per <u>hour</u> with **Minimum Charge per site visit \$100.00** for the following equipment:

- Grader
- Plow
- Tractor and Attachment (Mower/Disc/Packer)
- Backhoe

Daily

That Council policy be that Elton machinery rates are **\$100.00 per day** for the following equipment:
