

LICENSE TO USE ROAD ALLOWANCE (OTHER THAN TO BALE HAY)

THE RURAL MUNICIPALITY OF ELTON

(hereinafter the "Elton")

(hereinafter the "Licensee")

IN CONSIDERATION of the sum of ONE (\$1.00) DOLLAR paid by the Licensee to Elton, the receipt and sufficiency of which is acknowledged, Elton grants to the Licensee a right to use the road allowance as described below and as highlighted on the map on the reverse of this License,

(the "road allowance")

The terms of the License are as follows:

1. The road allowance may only be used by the Licensee for the following purposes (check all that apply):
 - a) Fencing for the purpose of pasturing livestock;
 - b) The growing of crops;
 - c) Beekeeping.
2. The Licensee agrees that they shall not use the road allowance for purposes which are unlawful or in contravention of municipal, provincial or federal legislation.
3. The Licensee shall be responsible for maintaining the road allowance at their cost, and to remove any fencing or other obstructions on the road allowance at the termination of the license.
4. The Licensee shall indemnify and save harmless Elton for any claims for loss, damages or injury arising out of the Licensee's use of the road allowance.
- 5 a) The term of the within license shall commence from the date hereof for a one year period, and shall automatically renew for consecutive annual terms until terminated for the purpose listed below (check all that apply):
 - a) Fencing for the purpose of pasturing livestock;
 - b) The growing of crops;
- 5 b) The term of the within license shall commence from the date hereof and expires on December 31 of year of issue.
 - c) Beekeeping.
6. The licensee shall have no rights or claim to the road allowance, other than as set forth herein.
7. Elton shall have the right to terminate the license:
 - i. Immediately in the event of a breach by the Licensee of the terms of the within Agreement;
 - ii. By giving the Licensee six (6) month's written notice of termination; or
 - iii. For Beekeeping purposes, if the Beekeeper has not met the standards set in Policy No. 36-2013.
8. The within Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective heirs, successors and assigns.
